(xvi) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, intuitions or associations with which this Trust is authorized to amalgamate.

**TREASURER:**

- a) The treasurer will act under the direction of the committee
- b) Any amount exceeding Rs. 10,000.- which is not required for immediate use shall be paid into such bank or banks as may be approved or by the committee. The treasurer shall ordinarily receive all payments and disburse the amount passed by the President and shall maintain proper books of accounts.

**TRUSTEE**

- 1. He/She will submit -annual progress reports and audited statement of accounts of the trust before the general body meeting.
- 2. He she will guide direct and supervise all the activities of the trust
- 3. He /she shall place the financial position of the trust in every meeting of the governing body.
- 4. He /she will receive grants, funds, donations and subscriptions on behalf of the trust

**INSPECTION OF REGISTERS.**

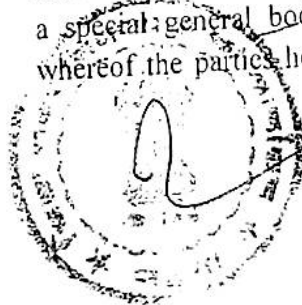
All registers will be kept in the registered office. Any member may inspect these registers with the prior permission of the settler - Cum - Chairman
